**MARCH 23 Departure** Your pilgrimage begins as you depart the USA.

**MARCH 24 Arrive in Rome, Italy** and transfer to the port of Civitavecchia to embark the *Costa Pacifica*.

**MARCH 25 Savona, Italy** Arrive this morning in the Italian Riviera. Today's shore excursion will be on your own to visit the French Riviera and the principality of Monaco, or the famous town of Portofino, Italy, or Genoa, the hometown of Christopher Columbus.

**MARCH 26 At Sea**

**MARCH 27 Katakolon (Olympia), Greece** Step back 2,000 years and imagine the roar of the spectators as athletes took their marks on the marble starting blocks in the stadium at ancient Olympia. The *Costa Pacifica* sails for Piraeus.

**MARCH 28 Athens and Corinth, Greece** The architectural splendors of the ancient city of **Athens** are as magical as ever. Follow your guide on a journey to the ancient **Acropolis** where you will see the **Propylaea**, the **Parthenon** and the **Erectheum**. View **Mars Hill** where Paul preached the gospel to the intellectual Athenian community of his day (Acts 17: 15-34). View the ruins of the **Agora**, ancient market place and center of Athenian public life, where Paul preached to the skeptical Athenians. You will view the **Olympic Stadium**, where the modern Olympics began. Travel to **Corinth** (Acts 18: 1-18), a city that inspired St. Paul's most familiar letter. You will visit the **Archaeological Museum**, the **Market Place**, and **Temples**. Walk among the ruins and stand on the **Bema** where Paul stood. Read Paul's letter to the Corinthians and visualize his address to the Gentiles as he began the task of building Corinth's church. The *Costa Pacifica* sails to Izmir. Lunch will be on your own today.

**MARCH 29 Izmir, Turkey** Journey to **Ephesus**, the marble city where Paul spent three years of his ministry. It was to this community that Paul may have written his Epistle to the Ephesians. The ruins of Ephesus have been restored much like the city was in Paul's time. You will visit the ancient **Agora** and imagine where Demetrius, the silversmith, sold his silver shrines of the Greek goddess Artemis. You will view the **Great Theater** and see the place where Paul witnessed faithfully for Christ. The third largest city in modern Turkey is **Izmir**, long a center for

Jewish and Christian communities. In Paul's day, the town was known as Smyrna. It was one of the Seven Churches of Revelation (Rev. 2: 8-11). You can still see the Agora, the colonnaded commercial center where Roman statues can still be seen.

**MARCH 30 At Sea**

**MARCH 31 Jerusalem, Israel** Dock in the port of **Ashdod** and travel to **Jerusalem**. Visit the **Upper Room**, the traditional site of the Last Supper. Visit the **House of the High Priest Caiaphas**, where Jesus was tried before the Sanhedrin. Stand upon the **Mount of Olives** and view the city as Jesus did. Wander among the olive trees of the **Garden of Gethsemane**. Enter the **Old City** and say a prayer at the Western Wall. Visit the **Pool of Bethesda** and walk along the **Via Dolorosa** to the **Church of the Holy Sepulchre**. Visit the Garden Tomb before returning to the ship. (Lunch will be on your own today.)

**APRIL 1 Cairo, Egypt** Dock in **Port Said** and travel to Cairo. Begin your tour of **Cairo** with a visit to the **Egypt Museum** which houses the **King Tut treasures** and many other artifacts from Egypt's long history. Visit the **Great Pyramids of Giza**, the last remaining ancient wonder, built before Moses and the Israelites were even in this ancient land. Return to Alexandria where you will reboard the *Costa Pacifica*.

**APRIL 4 Rome, Italy** Dock in the port of Civitavecchia and say good-bye to the *Costa Pacifica*. Travel to Ancient Rome where history is woven through the streets and neighborhoods as in no other city. Today you'll explore the many wonders of ancient Rome when you visit the magnificent **Colosseum**. From the most sacred hill of ancient Rome, **Campidoglio**, you'll view the **Forum**. You'll also view the **Circus Maximus**, **Mamertine Prison**, and the **Arch of Titus**, the famous **Baths of Caracalla** and the **Arch of Constantine**. You'll see the **Victor Emanuel Monument** and the **Monti Region**, Rome's most ancient neighborhood which spreads over three of her seven hills. Overnight in Rome.

**APRIL 5 Return to USA** Transfer from your hotel to the Rome Airport to begin your journey home.



## Enhance Your Journey with a Pre or Post Tour

### Greece Pre-Tour \$598

**March 23 Depart USA**

**March 24 Thessaloniki** Arrive in Thessaloniki, second largest city in Greece and capital of Macedonia. Paul preached in Thessaloniki during the winters of 49-50 AD and wrote two epistles to the ancient Thessalonians. During the city tour you will see the ramparts of the city, the triumphal Arch of Galerius starting the Via Egnatia, once a strategic artery of the Roman Empire and the Roman Agora where Paul preached. The monastery of Vlatadon was built on the location where Jason's house is believed to have stood and where Paul stayed during his visit to Thessaloniki. Overnight in Thessaloniki.

**March 25 Philippi** In Philippi, Paul was moved to preach his first evangelical sermon in Europe to women who had gathered at the river. Among them was Lydia, a cloth merchant, who became the first Christian to be baptized on European soil. Visit the place where this event is remembered and see a crypt dating from the Roman period, which is thought to have served as a prison for St. Paul. You'll also see the famous Acropolis, the Market Place, Basilica and the Theater. Overnight in Kalambaka.

**March 26 Meteora** In the rock forest of Meteora, famous Byzantine monasteries perch precariously on summits of soaring, sheer-sided grey rock pinnacles. You will visit one of these monasteries before continuing on to Delphi for overnight.

**March 27 Katakolon** Drive to Katakolon and embark. The *Costa Pacifica* sails for Piraeus.

### Rome and Pompeii Pre-Tour \$648

**March 20 Depart USA**

**March 21 Arrive Rome** and visit the catacombs and St. Paul Outside the Walls.

**March 22 - Christian Rome** Christianity came late in her long history, conquering and changing Rome in a way few other invaders have. **March 24 - Rome** Have the morning free before transferring to your ship this afternoon.
